NARRATIVE SUMMARY

The 7th Engineer Battalion continued support of the III Marine amphibious Force within the Danang area. Platoons from the attached 1st and 3rd Bridge Companies are rendering additional support in the Chu Lei, Hue/Phu Bai, and Dong Ha areas.

Company "A", 9th Engineer Battalion continued engineering operations on Route 1 between Danang and Thang Binh to upgrade Highway 1 for class 50 traffic inspite of intensive enemy sabotage and moderate flood damage.

Company "B", 7th Engineer Battalion reopened Route 12 after moderate flood damage.

Companies "A" and "D", 7th Engineer Battalion reopened Route 5 after extensive damage caused by the flood of 8 and 9 October 1967. (See TAB B)

Company "C", 7th Engineer Battalion completed 40% of the Ha Dong Bridge (AT 998707), a 340 pile bent design. Company "C" moved their CP from the 7th Engineer Battalion Cantonment to a new location in the area of Tuy Loan (AT 948708).

1st Bridge Company, 7th Engineer Battalion placed a class 55 M4 ferry at the Song Thu Bon (AT 925532), Namo Bridge site (AT 928842) and the Ha Dong River site (AT 990641).

3rd Bridge Company, 7th Engineer Battalion placed a class 55 M4/M4T6 ferry in operation at the NamO Bridge site.

Service Company, 7th Engineer Battalion provided 3,126,000 gallons of water from their nine (9) water points for use in the Danang TAOR.

REPORT OF FLOOD DAMAGE

A tropical storm moved into the Danang TACR on 8 and 9 October 1967 and created a flood condition that severed numerous lines of communications throughout the TACR. The following is a synopsis of the damage that was a result of the fore mentioned flood within the 7th Engineer Battalion area of responsibility.

By 1115 on 9 October 1967 the following conditions existed:

Route 5 from AT 912589 to AT 911577 was under 5' of water.

Routo 5 from AT 921577 to AT 925535 was under 51 of water.

Route 5 from AT 938716 to AT 939578 was under 2' of water.

Route 14 from AT 911591 to AT 912578 was under 5.51 of water.

Route 14 AT 922576 (East) under 3.51 of water.

Route 1 BT 135475 under 2' of water.

Route 1 South approach to Song Cau Lau Bridge under 31 of water.

Route 12 under 3 to 4' of water.

Anderson Trail BT 023637 under 2.51 of water.

NamO Bridge (AT 928843) 4201 M4T6 washed out. 70% lost or destroyed.

Liberty Bridge (AT 925533) 2040' pile bent structure. 600' section washed out and destroyed.

Bridge (AT 913588) 250' pile bant. Both abutments washed out.

Bridge (AT 866573) 96' pile bent. Superstructure completely washed out.

Bridge (AT 922605) 321 pile bent. Both abutments washed out.

Bridge (AT 993642) 336 M4/55 rendered impassable sustained moderate damage.

Bridge (AT 998707) 658' M4T6/60 rendered impassable sustained minor damage.

Bridge (BT 040762) 6751 Foot Ponton washed out. 75% lost or destroyed.

Numerous culverts were washed out in most areas of flooding and extensive erosion occurred in the low areas.

Route 5 between Song Tuy Loan and Dai Loc was respensed by 1 Nov 1967.

Route 14 was completely reopened by 6 Nov 1967.

Route 1 was completely reopened to traffic by 20 October 1967.

Route 12 including Cooper Bridge (BT 031649) was reopened by 24 October 1967.

Anderson Trail including Ha Dong Ferry was reopened by 26 October 1967.

The route 5 crossing of the Song Thu Bon was reopened by 22 October 1967.

Route 1 crossing at NamO was reopened by 12 October 1967.
