

1 March: Spread 175 cu.yds. of rock on Route 5 south of Phu Loc, Crushed 25 cu.yds. of rock. Replaced bridge on Route 33 with (3) 32"x48" culverts. Completed 6 culvert bunkers 8X8X8 at Cap E-4. Completed repairs of bridge on Route 1 at 018675.

2 March: Completed (1) one 4X10 head at CAG-2, completed (2) two Ammo Bunkers at CAP S-3. Have completed destroying 27 VC caves and bunkers, two French bunkers and one house with demolitions. Spread 90 cu.yds. of rock below Phu Loc on Route 5 south, crushed 30 cu.yds. of rock at An Hoa. Placed 190 cu.yds. of rock on Route 33.

3 March: Destroyed 4 damaged bunkers at CAP S-3, completed bunkers at CAP E-4.

4 March: Found triple culvert at AT 943670 blown, used 65 cu.yds. of fill and 15 cu.yds. of rock for repairs. Constructed bypass. Placed 130 cu.yds. of rock on Route 5 below Phu Loc.

5 March: Spread 80 cu.yds. of fines and graded Route 33. Destroyed one house and 3 bunkers at CAP D-7. Located one box mine at AT 941641, mine detonated while being grappled out crater was filled. Spread 95 cu.yds. of rock on Route 5 south of Phu Loc. Hauled, spread and compacted 1,180 cu.yds. of fill at Ammunition Storage area at the DaNang Airbase.

6 March: Filled one 8'X4' crater at 062655. CAP S-4 completed (1) one ammo bunker and 4 intermediate bunkers on berm line. Spread 1,000 gallons of asphalt on Route 5, Hill 37 and Maintenance area. Hauled, spread and compacted 1,478 cu.yds. of fill at Ammunition Storage area at the DaNang Airbase.

7 March: Completed bridge repair at 076559. Unloaded 3 cu.yds. of fill on sandbag culvert at 068563. Upgraded and placed 735 cu.yds. of fill on Anderson Trail west. 900 gals asphalt distributed on Route 12 east. 145 cu.yds. of fines spread and graded on Route 33. Poured footings for headwalls on Route 33. Emplaced 1,380 cu.yds. of fill to berm job DaNang Airbase.

8 March: Spread 115 cu.yds. of fines and 340 yards of fill on Route 33. Spillways for triple 48" culverts on Route 33 complete. 120 cu.yds. of fill hauled to eroded section on Route 5. CAP S-3 4 culvert bunkers complete. 780 cu.yds. of fill spread on Anderson Trail. Emplaced 1,390 cu.yds. of fill to berm job at DaNang Airbase.

9 March: CAG-2 living quarters and 4 culvert bunkers completed. 966 cu.yds. of fill spread on Anderson Trail west. 340 cu.yds. of fill hauled to eroded section of Route 5. Spread 130 cu.yds. of fill on Route 33. Emplaced 1,875 cu.yds. of fill at berm job at DaNang Airbase.

10 March: Completed one (1) 16X32 tin roof strong back at CAP B-1.

11 March: Repaired decking on bridge at AT 943691 Route 5 south. Spread 150 cu.yds. of fill on eroded section of Route 5. Spread 265 cu.yds. of fill and 115 cu.yds. of fines on Route 33. Emplaced 3,191 cu.yds. of fill at berm job at the DaNang Airbase.

12 March: Completed bridge on Route 6 at AT 957717. 6X10 4 hole head complete at Oldfield. Anderson Trail west hauled and spread 990 cu.yds. of fill. Spread 60 cu.yds. of fill and 40 cu.yds. of rock on Route 33. Replaced bridge on Route 33 at AT 928794 with (2) 36" culverts. Emplaced 3,060 cu.yds. of fill at berm job at DaNang Airbase.

18 March: Graded Route 5 from AT 945707 to AT 918728. Spread 150 cu.yds. of fines and 150 cu.yds. of fill on Route 33. Replaced bridge on Route 33 at 908792 with 2-36" culverts. Completed 16X32 strongback and one (1) 6X10 4 holer, at CAG-2. Hauled and spread 600 cu.yds. of fill at the Ha Dong Bridge approach. Spread and graded 378 cu.yds. of fill at tank by-pass on Route 1B. Checked all bridges on Route 1 from the ferry to the Song Thu Bon Bridge. Emplaced 3,106 cu.yds. of fill at berm job at the DaNang Airbase.

19 March: Spread 250 cu.yds. of fines and 260 cu.yds. of fill on Route 33. Completed one (1) culvert bunker, one (1) 8X8 bunker at CAP S-1. Dug 120' of trench line at 7th Comm Bn CP area. Hauled and spread 335 cu.yds. of fill at tank by-pass. Repaired ramp on bridge at Song Thanh Quit. Emplaced 2,287 cu.yds. of fill at berm job at the DaNang Airbase.

20 March: Began clearing area for 60" culvert at Route 5 north at 946707. Assembled 36' of 60" culvert and 36' of 48" culvert. Hauled and spread 450 cu.yds. of fill at the tank by-pass. Spread 100 cu.yds. of fines and 200 cu.yds. of fill on Route 33. Repaired M4T6 pontoon at Song Cau Do. Emplaced 1,040 cu.yds. of fill at berm job at the DaNang Airbase.

21 March: Removed bridge at AT 946707 on Route 5. Completed one (1) culvert bunker at CAP S-1. Spread 250 cu.yds. of fill on Route 33. Checked ferry at Song Thu Bon. Emplaced 2,144 cu.yds. of fill at berm job at the DaNang Airbase.

22 March: Completed replacing bridge on Route 5 north at AT 946707. Emplaced 160 cu.yds. of fill at bridge site AT 946707. Installed five float raft class 60 at BT 430109. Repaired pontoons on bridge at Song Cau Do. Completed (1) 16X36 strongback. Hauled and graded 366 cu.yds. of fill in preparation for helo pad at 3/27 CP. Hauled and spread 155 cu.yds. of fill on Route 33. Emplaced 2,579 cu.yds. of fill at berm job at the DaNang Airbase.

23 March: Spread 6,000 gallons of oil on Route 5 south. Hauled, spread and graded 336 cu.yds. of fill on the tank by-pass. Loaded one (1) M-6 bridge on trailers at FLC for delivery to ferry pier at III MAF. Emplaced 2,723 cu.yds. of fill at berm job at the DaNang Airbase.

25 March: Graded Route 5 north from AT 946707 to AT 912743. Checked all bridging on Route 1 from Song Cau Do to the Song Cau Lau. Hauled 105 cu.yds. of sand from 3rd 8" How Btry. Hauled and spread 666 cu.yds. of fill to tank by-pass on Route 1B. Emplaced 2,000 cu.yds. of fill at berm job at the DaNang Airbase.

26 March: Spread 6,000 gallons of oil on Route 5 from AT 911743 to AT 925607. Hauled and spread 936 cu.yds. of fill at the tank by-pass on Route 1B. Completed (8) eight strongbacks at 2/27 CP area. Hauled 138 cu.yds. of sand for the CAP Units. Hauled 135 cu.yds. of fill to 3rd 8" How Btry. Emplaced 3,791 cu.yds. of fill at berm job at the DaNang Airbase.

27 March: Spread 6,000 gallons of bunker oil on Route 5 south between AT 945706 and AT 942662. Checked all bridges on Route 1 from the Song Cau Do to the Song Cau Lau. Assisted CAP Units by hauling 60 cu.yds. of sand. Emplaced 1,850 cu.yds. of fill at berm job at the DaNang Airbase.

28 March: Checked all bridges on Route 1 from the Song Cau Do to the Song Cau Lau. Hauled and spread 100 cu.yds. of fill on Route 33. Repaired bridge on Route 4. Removed bridge at AT 960706 in preparation for installation of two culverts. Replaced decking on bridge at AT 962716. Hauled and spread 900 cu.yds. of fill and 6,000 gallons of bunker oil on Route 12 east. Spread 5,500 gallons of bunker oil on Anderson Trail west. Completed (6) six 16X32 strongbacks at the 2/27 CP area. Emplaced 1,960 cu.yds. of fill at berm job at the DaNang Airbase.

Maintenance

The Battalion Maintenance Platoon completed 51 Motor Transport work orders during the month of March. A total of 31 work orders were submitted, 12 were sent to Maintenance Battalion. Total work orders for Engineer Equipment number 113 and 92 completed and 18 were sent to FSR.

Messing

The Battalion Mess Staff continued to provide four meals daily except on Sunday; the fourth meal being a midnight ration for night crews. On Sunday a brunch replaces breakfast and dinner.

Medical

The Battalion Aid Station treated 651 Military and 20 Vietnamese. During the month of March the Dental Clinic treated 299 Military and 18 Vietnamese.

g. Civil Affairs/Civic Action

(1) The civic action program continues on a daily basis.

(2) Activities were as follows:

(a) The MED CAP program provided treatment to two hundred fifty three (253) persons.

(b) The battalion sponsored, Vietnamese brickyard produced a total of twenty six thousand four hundred thirty one (26,431) soil bricks.

(c) A total of twenty one thousand eight hundred thirteen (21,813) bricks were released from the 7th Engineer Battalion Brick Factory during the month of March for various projects.

(d) Seven (7) scholarships ere given to Vietnamese children who showed good academic ability.
